New Password. Ann M Haralambie. In the minority of unfounded cases, [50] the judge will conclude that the accusing parent was intentionally making a false allegation, as occurred in one Manitoba case, where the judge concluded: [51].

On the other hand, if the accusing parent appears to be mentally unstable or deranged. Sometimes, one party will introduce a videotape of an investigative interview with the child. A parent may have an expert critique the work of a court-appointed assessor or state-employed child welfare investigator, in an attempt to persuade the court that the first assessment was incompetently conducted. This subsection does not apply if, after the date of the conviction, or the date of the finding in a fact-finding hearing described in this subsection, the biological parents cohabit and establish a mutual custodial environment for the child.

At the court shall accept, as conclusive proof of the sexual assault, a guilty plea. The court must then consider the effect of false allegations of child sexual abuse on the best interests of the child when making a decision of custody.
